



















What suggestions for improvement do you have?

- 1. De lectures kunnen iets langzamer gaan. Bijvoorbeeld: de lecturer zei vaak "write this down", maar ging dan zo snel waardoor we het niet bij konden houden en niet alles op konden schrijven. Ook zou ik het fijn vinden om wat eerder/sneller feedback te krijgen. Ik had al meer dan de helft ingeleverd voordat ik feedback kreeg.
- 2. It's great that Wynand answered all questions, but sometimes it would be better to keep the answers shorter, because that can make people more confused. Also for the seminars, I would have preferred to do the feedbacks for the Peer reviews on my own time and talk more about the texts in the seminar. Four assignments and four peer reviews plus the exams are a bit much in 6 weeks.
- 3. I thought the course had a couple of flaws. Firstly, the sheer amount of work (especially texts to read) took some of the fun out of the subject for me, furthermore it meant that there wasn't much time to gestate on each topic that we covered, which hindered the development of my own insights. Secondly, the course had to many essay questions to answer etc.., this meant that the lecturer was swamped in marking to do which meant we got very little feedback on each piece of work we did and feedback wasn't given when the assignment was still fresh in our minds. I would have improved more if I had done less assignments but gotten more feedback. Thirdly, the seminars were a little underwhelming. Part of the appeal of PPE is the ability to discuss and form opinions with your seminar group, but I felt that this was lacking throughout this course. Finally, the volume during the lecture was a little too loud.
- 4. The lecturer cannot demand that students respect him and his ways of teaching without showing respect back. And way to much on the slides they shouldn't be texts
- 5. I really like the course and it shifted my worldview and way of thinking. there were too many assignments in the end so it got confusing with the overlapping deadlines. - 10. Time management is hard, there are many readings, and I understand that the readings are really useful, however, the problem comes when students shift from learning and having time to understand and interiorise the content, to automatic mode, where they just do what they are told to do because of the fear of failing, hence, not wanting to understand, but being forced to.

- 12. Since many readings cited important historical events that were also discussed in the lectures, I would suggest to provide a little historical background just to have a deeper understanding of the mechanisms of politics.
- 13. I think that having more time during the midterm will help the students to improve their writing. In addition, I think that it would be better to have few lectures about hystory before the starting of the course in order to be able to apply deeply the concepts covered.
- 14. Organization! We never got any grades back (just one assignment) hence we don't know how well we are doing, how we can improve, what to build on or anything. The seminars were disorganized and I felt as if they could've built on the lectures a lot more (ie explaining the concepts, cases, definitions, etc)
- 15. The seminars were not worthwhile. Most of what was discussed could have been done without contact hours. The peer reviews could've been done at home, and the assignment feedback is only really useful if it is tailored to your own assignment.

- 18. I think the seminars could have had more use, by really discussing what we learnt in the lectures. In my opinion, the seminars were a little bit unnecessary in the way they were given. For the lectures, 5-10 min break in the middle of the lecture, to make sure everyone stays focused.
- 19. The workload is a bit overwhelming...it's hard to keep up with the readings, especially since it's not the only course we had during period 2.
- 20. Building up before one gets into actual details, otherwise it is very hard to navigate, and the concepts are too abstract.
- 21. The seminars should be less peer reviews and more discussions
- 22. It was sometimes hard to follow the different theories, as we read 3 books simultaneously (plus essay from other authors) this became confusing sometimes and it is quite hard to get a general overview, especially as complete amateur in political science
- 23. The one complaint I would make would be to get grades back faster. I am fully aware that grading

papers is long and daunting, but completing four assignments and one midterm exam basing oneself only on one grade is hard. There is very little help given in this sense, as critical feedback is crucial to improve.

- 24. The lectures were very dry and theoretical, which is sad because the topics themselves very interesting I wish there would have been more examples given for a more graspable and engaging presentation. Further, not receiving proper feedback or grades throughout the entire period (except for the first Assignment) made personal improvement hard since it was not clear what we needed to work on personally or how well we are doing. Having a lot of readings and four assignments without receiving feedback or grades on time is pretty discouraging and demotivating. The seminars didn't help much for the exact same reason the course would have been more interesting and motivating if we would have discussed the course material and readings and discussed contemporary issues regarding that matter (like we did in Ethics, for example). As the model answers were provided on canvas anyway, going to the Seminars didn't feel very useful or meaningful. However, Baris was very nice and dedicated to make us understand the topics!!
- 25. - 26. Wynand is too strict. For example, for a take-home exam with a deadline at x hour, if a student submits it at x hour instead of x hour minus one minute, he substracts at least 4 points out of 10, which dooms any student to not pass the exam, because Wynand says nothing is ever a 10/10. Wynand is too strict and it's noticeable that we are the first 1st year students he has had. The exams are too long and his expectations too high. For instance, he says that for an assignment we shouldn't spend more than 2 hours writing it (which isn't enough for everyone). Although he says this, our take-home exam was 2 hours and 15 minutes and the equivalent in assignments was 3 of them. Moreover, in all the period he has only graded one paper. When at the moment we have submitted four of them. The feedback is poor and we don't know how to make them better. We are lucky to have Bariş as a seminar teacher.
- 27. If Wynand could speak a bit slower it would be easier to follow. There were a lot of academic terms to get used to, and when said really fast I easily lost track of what the point of the talk actually was. Seminars: The seminars were really not that useful. Baris is great, it's nothing on him. It just seems likely there wasn't really any content covered in the seminars besides peer review. I would have liked more class discussions about the readings and examined more examples where the text theory could be applied. In our Ethics course, we had this concept that for every seminar, we had to each prepare answers for a few different basic questions, which we then briefly discussed in class. This really helped us understand all the definitions, theories, and who argues for what. I could see the same concept work in this politics class.

- 30. I would have liked to see short reflections and outlooks at the beginning/ end of each lecture to better link the knowledge. This is, what are the central questions under each topic. Also, a handout with key definitions such as for terms like "institutions" would help students to come to grips with the jargon used in the political science to avoid ambiguities.
- 31. maybe reduce the number of assignments or the number of questions in the assignments. We have yet to receive most of our grades and it would've been helpful for assignments to have more than one graded assignment and it's feedback to look back on before turning in the others. Sometimes I did not learn a lot during the seminars so working on their structure might be good for next year
- 32. Very little application to real world politics and modern day politics. Grading was very slow we don't know how well we did in previous assignments. Seminar instructor Baris helped the most he could but the contents of the seminars could have been more interesting and expanding on concepts from the lectures.
- 33. Redesign the tutorials! They would have been more useful if actual political discussion had happened. We talked a lot about how to do assignment ecc but barely about the actual content of the readings.
- 34. I would have liked it if there were more basic thinking exercises or interesting discussions during seminars. They were very under utilized. Secondly I felt like it wasn't really as much an introduction as it was just a random start. The goals of political science, methods of research, common grand theories. These were all a bit lacking. I really liked the substance but unlike Ethics in P1 it didn't feel like a real intro course.
- 35. I think the seminars were not very useful and that there were not clear instructions about what we were supposed to do. I do not think the seminar teacher really knew how to help us. I would suggest that maybe next year, reading some extracts from the text during the seminar sessions would be very helpful.
- 36. It would be nicer if we recieved our grades and feedback sooner from the assignments. I would also suggest that maybe in the seminars we could discuss the lecture topics in a more practical and relevant current context.
- 37. Give feedback on the assignments before giving new assignments. Now we have to make assignment 4 with only assignment 1 graded. During the lecture, the pace should be way lower, this was too fast. Seminars were quite useless, give the seminar teacher more time to explain difficult parts of the lecture/readings.
- 38. could be more improvements on the exams
- 39. It was overall great.
- 40. The seminars should have more focus on the course material and possibly act as reinforcement on important lecture concepts.
- 41. The content of the seminars and the lectures did not always 'connect'. Also, some help for coping with all the readings would be nice.
- 42. just any method to make us get our grades back faster (whether that's less final assignments (keep peer reviews, but for example Wynand randomly selects peer reviews from students throughout the period so we are still incentivised to put in effort, and get feedback (but not as much as he expected to give us, since that was clearly too much)).

- 44. the lecture slide could've been designed more clearly with shorter bullte points instead of whole sentences, the seminars could've included more discussions about the material learned and i wish we would've discussed more contemporary real world examples applied to the theoretical topics we learned
- 45. Sometimes I wasn't quite sure what linked the seminars to the lectures. I think they could be improved so that students could study the material more in depth.

- 46. Maybe the interaction between the seminars and the lectures could be a bit more direct, but it is still good
- 47. Seminars could be more useful. Wynand could be a little more respectful to his students.
- 48. I would suggest to make the seminars more lively in order to be able to actually discuss the texts we read and benefit from an exchange of views.
- 49. I think the seminar could have been way more useful, because apart from the times when we did the peer reviews I felt like I didn't learn much. It would be better probably if the seminar was a moment where we could get good clarifications about the topics we study. I always had a feeling of confusion because it felt like if there was a lack of communication between the lecturer and the seminar teacher. Also, the workload takes up a really considerable amount of time and I found myself struggling to keep up with both subjects of the period. I had to always give priority to politics because otherwise I would have fallen behind. Maybe some readings were not extremely necessary to the full understanding and having a bit less to do would have been better.
- 50. I would suggest different organisation of seminars. I found peer reviews very useful, but maybe students could give feedback at home and discuss the topic of the lecture during the seminar instead. Nevertheless, i must emphasises that the seminar teacher was always ready to answer any questions regarding the lectures or course materials.
- 51. we had a lot of assignments and did not receive any feedback or grades from them until the end of the course, if the lecturer can't keep up with the workload how can he expect the students to. the topics were kind random and didn't connect to each other coherently. lectures and seminars were completely separate and it was hard to follow both.

In addition to that the lecturer often made mean comments in the lecture to and about students. The way of explaining and the design of the lecture slides were definitely not compatible for first-year students. The lecturer cared more about using very scientific complex wordings and phrasing than about making the content understandable for young students. All readings by famous scientists were more understandable than the lecturer's scientific works we were forced to read.


